## Open Meeting June 21, 2024 Joint Corporate and Governing Board of Directors Meeting MINUTES

- 1. Notice of Meeting
  - a. Pursuant to Arizona Revised Statutes (A.R.S.) § 38-431.02, notice is hereby given to the members of the Arizona Language Preparatory Board of Directors and to the general public that the Board will hold a public meeting, open to the public as specified below. - b. Mandarin K-2 position updates and plan
  - i. Reviewed updates; candidate FZ is completing a master's program at John's Hopkins and is considered a very good candidate for the mandarin K-2 position, with required paperwork in process; KR motioned to approve a conditional offer, pending completion of required paperwork, and BM seconded; EV, MG, KR, LC, and BM all in favor
